(Access is limited, 110v only.) All electrical cords used must be three-wire grounded, UL-Approved, and rated for outdoor use. The 4th of July Committee/City of Sierra Madre may restrict the use of heating and/or cooking appliances due to their high wattage. Electric warming units, frying pans, large coffee pots, and other appliances may not be permitted if excessive electrical load cause circuit breakers to trip.

Participants agree to abide by all rules and regulations set forth by the 4th of July Committee and the City of Sierra Madre. All booths must be operated by and staffed by business listed above. Participants will provide their own booths, supplies, and trash containers. Participants will be responsible for cleaning all trash in and around their booth area. Participants selling food/beverage are responsible for conforming to all

applicable rules and regulations set forth by the Los Angeles County Health Department.
